Re: Demand to Cease and Desist from Acts of Defamation

Dear Dr. Gorski:

I am counsel for Gary Null, Ph.D. If you are represented by legal counsel, please direct this letter to your attorney immediately and have your attorney notify us of such representation.

You are hereby directed to cease and desist from all defamation of Gary Null's character and reputation.

An internationally renowned expert in the field of health and nutrition, Gary Null, Ph.D. is the author of over 70 best-selling books on healthy living and the director of over 40 critically acclaimed full-feature documentary films on natural health, self-empowerment and the environment. He is the host of The Progressive Commentary Hour and The Gary Null Show, the country's longest running nationally syndicated health radio talk show, which can be heard daily on the Progressive Radio Network.

Throughout his career, Gary Null has made hundreds of radio and television broadcasts throughout the country as an environmentalist, consumer advocate, investigative reporter and nutrition educator. Numerous Gary Null television specials have appeared on PBS stations throughout the nation, inspiring and motivating millions of viewers. He originated and completed more than one hundred major investigations on health issues resulting in the use of material by 20/20 and 60 Minutes. Dr. Null started this network to provide his followers with a media outlet for health and advocacy.

You, on the other hand, choosing to ignore or deny these facts have undertaken a long personal vendetta against Dr. Null and in the process have been engaging in acts of defamation by making statements without factual basis or based on unverified hearsay for the purpose of harming Dr.

Null's reputation. Whether in his Wikipedia so called biography or in your own various writings you have referred to Dr. Null as a "quack" in every conceivable context and spread vicious lies about him, including that he promotes pseudoscience, was almost killed with his own supplements and that others were hospitalized, that he is an AIDS denialist, that Union Institute and University is a "correspondence college" that was not accredited to grant the degree Dr. Null received, accusing him of not supporting science, alleging his positions are motivated by profiteering, among others. We are still reviewing the full extent of your defamatory acts, both those that you wrote and those that you spread or republished knowing of their falsity or with reckless disregard of their truth.

This communication serves as a pre-suit letter demanding that you provide us written assurance within 10 days that you will withdraw all defamatory writings on Dr. Null, that you will request in writing the withdrawal of all defamatory statements you made about Dr. Null on third party web sites (with copies of said writings sent to us to prove that you have done so) and respond with your written assurance that you will cease and desist from making additional defamatory statements.

If you do not comply with this cease and desist letter within the aforementioned time period a lawsuit may be filed in the proper jurisdiction seeking monetary damages as well as pursuing all available legal remedies for your defamation.

This letter is not intended as a limitation on my client's rights and remedies, all of which are specifically reserved.
